2009: CHAMPIONHIP YEAR FOR FLOTILLA 87





Rules of the Road

Do you know your day shapes?



In my previous article which appeared in WaterLine, I talked about navigation lights and the basic configuration of red and green sidelights and the all-round white light. These lights are designed and placed on-board to alert vessels what direction the other vessel is traveling or may be doing during night-time hours or at times of restricted visibility.

Another means of communicating to other vessels during daylight hours are day shapes. The day shapes are in addition to the navigation lights and alert you to their vessel's special conditions or activities. These shapes are called day shapes because they are usually only visible during the daylight hours.

These day shapes are described in the Navigation Rules as are their placement on each type of vessel. The Rules are the NAVIGATION RULES (Nav Rules) which are in two parts. The first are the 72 COLREGS, formally known as the Convention on the International Regulations for Preventing Collisions at Sea. The second is the Inland Rules. Both were adopted by the United States and the Coast Guard is charged with their enforcement in U.S. waters. These Rules apply to all vessels on international and inland waters.

Day shapes are always black and may be balls, cones, diamonds, cylinders or basket. I'll try to describe some of the more common day shapes we may see in our area.

International Rules for sailing vessels under sail and also being propelled by machinery (power) shall exhibit where it can best be seen a conical shape, apex downwards. This is also described as an inverted cone. This is the same for Inland Rules except that vessels less than 12 meters are not required to exhibit this day shape, but may do so.

For those of us not accustomed to metric conversions, 12 meters is approximately 39.4 feet in length.

Another shape we may see is two conical shapes (cones) apex to apex displayed on fishing vessels. Both International and Inland Rules describe fishing vessels of many configurations and activities. The lights these fishing vessels are required to display change based on their length and activity but all are required to display the cone day shapes. A fishing vessel less than 20 meters long may instead show a basket. When not actively engaged in fishing, these vessels shall not display the lights and shapes of a fishing vessel but the appropriate lights for a vessel of her size.

Vessels constrained by draft (usually very large vessels) are only recognized under International Rules. Therefore, if you are underway in international waters and see a cylinder displayed, keep out of its way. It may only navigate in marked channels toward its destination.

As a courtesy to other boaters and in consideration of the many shoals, sandbars and oyster beds in our area, please be aware there are many smaller boats on inland waters that may only navigate in marked channels. At my radio console at work I frequently overhear professional and recreational boaters warning other boaters there may be shallow water ahead of them. Unfortunately, I also hear some boaters giving a verbal raspberry to an inconsiderate boater who forced someone out of the channel they were safely navigating within.

This brief narrative of day shapes is not intended to cover all the many vessels required to display day shapes. A thorough study of the Nav Rules is in order if you want or need to know what shapes mean or when to display them.
