Excuses

When I first heard the news reports of the Costa Concordia cruise ship's accident off the coast of Italy, January 13, I speculated that the details of this accident might be similar to the Queen Elizabeth II accident off Martha's Vineyard in August 1992. In that accident, the QE2 had hit charted rocks and, because the crew performed admirably to keep the passengers informed and control damage, there were no injuries.

I recall the final determination was a combination of charted depths were significantly less than that shown on their charts and the physics of a large cruise ship's actual depth requirement when underway. The report of this incident can be found through the website www.theqe2story.com.

In the following days since the Costa Concordia hit a reef then was grounded to prevent it from sinking, I tried to read and listen to as many reports of the accident as I could. One very disturbing detail was how the captain of the cruise ship got off the ship before all the passengers were safe and accounted for. His excuse, as I heard it on the news was that he happened to "trip and fall" into a life boat! To make matters worse, the captain argued with the Italian Coast Guard officer over orders to return to the ship to direct rescue efforts.

I am sure more details will emerge in the days and weeks to come. In the meantime, a little closer to home, excuses seem to be just as incredible from the causes of accidents.

In an article written in March of 2009 by Arlyn Hendricks, president of the National Water Safety Congress, here are a few more excuses to ponder:

It was a warm, sunny day; we did not realize how cold the water was.

We thought we had the right of way.

I did not realize how quickly a child can get in the water.

Life jackets are too hot and uncomfortable to wear.

I only turned my head for a second.

The wind was not blowing when we launched the boat.

I can swim well enough to make it to shore.

We did not see the other boat.

We weren't really going boating; we were just hunting ducks.

It was a bright moonlit night so we thought we did not need lights for other boaters to see us.

We thought she did not need a life jacket on; we were close by if she got in trouble.

Mr. Hendricks further writes that most of these statements were made following accidents that ended in tragedies. Can you imagine what those tragedies were?

Whatever the facts are regarding boating accidents, it is important to remember that boating in any form or fashion, from recreational to professional, being on the water has its dangers. Everyone must be aware of their surroundings, plan ahead and be prepared. Know what to do to avoid an accident and know how to react in the event there is one.
